 During internal review, DOF determined additional policy changes required to meet goal of including carbon offset opportunities July 2025: Resume Public Scoping efforts

 Additional Policy developments to create opportunity for verifiable carbon offset projects Winter 2025: Public Review of plan draft

- Public review period will last a minimum of 30 days.
- Public meetings in Haines and Klukwan approximately halfway through the review period
- DOF aims to complete public review before May 2026


